The following definitions apply in this Article:

Classified motor vehicle. - A motor vehicle classified under this Article.

Collecting authority. - The Division of Motor Vehicles or an agent contracting with the Division of Motor Vehicles.

Motor vehicle. - Defined in G.S. 20-4.01(23).

Municipal corporation. - Defined in G.S. 105-273(11).

Public service company. - Defined in G.S. 105-333(14).

Registered classified motor vehicle. - Any of the following:

a.A classified motor vehicle that has a registration plate issued under Article 3 of Chapter 20 of the General Statutes and whose registration is current.

b.A classified motor vehicle transferred to an owner who has applied for a registration plate for the motor vehicle.

Registration fees. - Fees set out in G.S. 20-87 and G.S. 20-88.

Unregistered classified motor vehicle. - A classified motor vehicle that is not a registered classified motor vehicle.
