- § 106-405.2(a)

No person shall feed garbage to swine without first securing a permit therefor from the North Carolina Commissioner of Agriculture or his authorized agent. Such permits shall be issued for a period of one year and shall be renewable on the date of expiration.
- § 106-405.2(b)

No permit shall be issued or renewed for garbage feeding under this Part in any county or other subdivision in which local regulations to prohibit garbage feeding are in effect.
- § 106-405.2(c)

This Part shall not apply to any individual who feeds only his own household garbage to swine: Provided, that any such swine sold or disposed of shall be sold or disposed of in accordance with rules and regulations promulgated by the State Board of Agriculture.
- § 106-405.2(d)

This Part shall not apply to any person who holds a valid federal permit under the Swine Health Protection Act, P.L. 96-468.
