- § 122E-3(a)

There is established a North Carolina Housing Trust Fund, separate and distinct from the General Fund.
- § 122E-3(b)

The Fund shall consist of monies received under this act and any other sources of revenue, public or private, dedicated for inclusion in the Fund.
- § 122E-3(c)

The State Treasurer shall serve as trustee for the Fund. The Treasurer shall invest the North Carolina Housing Trust Fund revenues he receives as provided in G.S. 147-69.2(b). The Treasurer shall provide the Agency with quarterly and annual reports of Fund revenues and interest earnings.
