- § 131E-137(a)

Every county shall provide part-time, intermittent home care nursing services, and at least one of the following home care services: part-time, intermittent physical therapy, occupational therapy, speech therapy, medical social work, or home health aide services.
- § 131E-137(b)

- § 131E-137(c)

These services shall be provided by a home care agency licensed under this Part. The county may provide these services by contract with another home care agency in another county.
- § 131E-137(d)
