- § 20-289(a) The license fee for each fiscal year, or part thereof, shall be as follows:
- (1) For motor vehicle dealers, distributors, distributor branches, and wholesalers, one hundred fifteen dollars and fifty cents (\$115.50) for each place of business.
 - (2) For manufacturers, two hundred fifty dollars and fifty cents (\$250.50) and for each factory branch in this State, one hundred sixty-seven dollars and twenty-five cents (\$167.25).
 - (3) For motor vehicle sales representatives, twenty-five dollars and fifty cents (\$25.50).
 - (4) For factory representatives, or distributor representatives, twenty-five dollars and fifty cents (\$25.50).
 - (5) Repealed by Session Laws 1991, c. 662, s. 4.

§ 20-289(b) The fees collected under this section shall be credited to the Highway Fund. These fees are in addition to all other taxes and fees.
