§ 46A-56(a) If no exception to the report of the commissioners is filed within 10 days of service of the report on all the parties, the clerk shall confirm the report.

§ 46A-56(b) If an exception to the report of commissioners is filed, the clerk shall do one of the following:

- (1) Confirm the report.
- (2) Recommit the report for correction or further consideration.
- (3) Vacate the report and direct the same commissioners to reapportion the real property.
- (4) Vacate the report, discharge the commissioners, and appoint new commissioners to view the real property and partition it.

§ 46A-56(c) Appeal from the clerk to superior court of an order of confirmation of the report of commissioners is governed by G.S. 1-301.2 except that the judge may take only the actions specified in subsection (b) of this section and shall not adjudge a partition of the property different from that made by the commissioners.

§ 46A-56(d) After confirmation of the report, any party may seek relief from the order of confirmation for mistake, fraud, or collusion by a motion in the proceeding. This relief, however, shall not affect an innocent purchaser for value and without notice. (1868-9,
