Commission. - The Well Contractors Certification Commission established in Article 7B of this Chapter.

Department. - The Department of Health and Human Services.

Person. - A natural person.

Secretary. - The Secretary of Health and Human Services.

Well contractor. - A person in trade or business who undertakes to perform a well contractor activity or who undertakes to personally supervise or personally manage the performance of a well contractor activity on the person's own behalf or for any person, firm, or corporation.

Well contractor activity. - The construction, installation, repair, alteration, or abandonment of any well.- (1997-358, s. 2; 1997-443, s. 11A.119(b); 2002-165, s. 1.1; 2015-241, s. 14.30(u), (v); 2021-180, s. 9G.7(a).)
