The Board may establish fees, not to exceed the following amounts:

Application and an examination, one hundred dollars (\$100.00).

Issuance of a license, five hundred dollars (\$500.00).

Renewal of a license, three hundred dollars (\$300.00).

Renewal of a license, an additional late fee of two hundred dollars (\$200.00).

Duplicate license fee, twenty-five dollars (\$25.00).

Duplicate wall certificate fee, fifty dollars (\$50.00).

Labels for licensed acupuncturists, one hundred fifty dollars (\$150.00).

Returned check fee, forty dollars (\$40.00).

Licensure verification, forty dollars (\$40.00).

Name change, twenty-five dollars (\$25.00).

Continuing education program approval fee, fifty dollars (\$50.00).

Continuing education provider approval fee, two hundred dollars (\$200.00).

Initial school application fee, one thousand dollars (\$1,000).

Renewal school approval fee, seven hundred fifty dollars (\$750.00).

Inactive license renewal fee, fifty dollars (\$50.00), payment due for each two-year extension.
